2024 – 2025 BEHAVIOR CONTRACT / PERMISSION SLIP FOR CHSMBPAI ACTIVITIES AND EVENTS

ADMITTANCE:

- 1. Admittance is subject to Band Director and CHSMBPAI approval.
- 2. Any Band Member attending must be a member in good standing, in accordance with Article II, Section 2 of the CHSMBPAI bylaws, regarding the payment of dues, or, if not a Band Member, must be the guest of a Band Member in good standing.
- 3. Attendance at CHSMBPAI activities and events is a privilege, which may be revoked for lack of responsibility at school, including but not limited to: unpaid fines, serious discipline issues, unsatisfactory attendance, or failing grades.
- 4. No attendee will be permitted late to any event unless prior arrangements have been made with the CHSMBPAI Executive Board.
- 5. Any non-Band Member guest must be accompanied by a CHS Band Member, must be under the age of 21 and shall not be a middle school or grammar school student. Late entrance of a guest will be permitted only if prior arrangements have been made with the CHMBPAI Executive Board.
- Band Members and guests are not permitted to leave an event before it is completed. All Band Members or guests wishing to leave early must see an attending Chaperone for permission due to any extenuating circumstances.
- 7. Band Members must be picked up by a parent/guardian at the conclusion of the event. Any Band Member in the possession of a valid driver's license may drive themselves home at the end of an event.

RULES:

- 1. All rules as defined in the CHS Mustang Band Student Manual are in full effect during any social event.
- 2. Any Band Member or guest suspected of using alcohol or any controlled or illegal substance prior to or during any event will be removed from the event. Clifton High School, the Police Department, and their parents will be notified. Education codes prohibit the use/possession of alcohol, intoxicants, and controlled substances at school, on the way to/from school or at any school events. All Band Members and their guests may be checked for illegal or controlled substances prior to entry of any social event.
- 3. Any Band Member or guest exhibiting disruptive behavior will be removed from any event. Band Members will be held accountable for the behavior of their guests. Attending Band Members are required to inform their guests of all contract rules.
- 4. No reimbursement or refund will be given to anyone removed from a CHSMBPAI event.
- 5. Any breach of this contract (including forgery of this contract) will result in the Band Member being banned from future CHSMBPAI events, including the Winter Semi-formal and Band Awards Dinner. The suspension/ban will be enforced for one year.

2024 – 2025 BEHAVIOR CONTRACT / PERMISSION SLIP FOR CHSMBPAI ACTIVITIES AND EVENTS

CONDUCT:

- 1. Any dance considered dangerous, aggressive, or suggestive in any manner will not be permitted. Chaperones will determine what forms of dance are appropriate.
- 2. Appropriate dress is required for all CHSMBPAI events, in accordance with the Clifton High School Dress Code. Semi-formal attire is required for the Winter Semi-formal and the year end Awards Dinner.
- 3. Violation of the dress code may result in non-admittance to an event. If a dress code violation occurs after admittance, the Band Member or their guest may be removed from the event.
- 4. For ticketed events, tickets are not transferable and are non-refundable.
- 5. All Band Members and guests will abide by the rules as outlined in the CHS Mustang Band Student Manual. Behavior at any CHSMBPAI event should reflect both a positive and respectful attitude.

DRESS CODE: FOR Winter Semi-formal and Awards Dinner

ACCEPTABLE ATTIRE:

- 1. Collared shirt and tie
- 2. Dressy top
- 3. Dress pants
- 4. Semi-formal dress (appropriate length)
- 5. Dress shoes/heels

PROHIBITED ATTIRE:

- 1. Clothing that exposes the midriff area
- 2. Excessively low-cut necklines
- 3. Jeans
- 4. Shorts
- 5. Any clothing that violates the Clifton High School Dress Code
